Chairman's Statement

In the first half of 2020, the global economy suffered seriously due to the impact of the COVID-19 pandemic (the "**Pandemic**"). There were some signs of improvements in the second quarter after the deployment of monetary and relief measures by various governments. However, the GDP of the United States (the "**US**") and the European Union (the "**EU**") still suffered contractions of 3.5% and 6.2% respectively for the full year of 2020. The government of the People's Republic of China (the "**PRC**") has been able to contain the Pandemic in the second quarter of 2020 and its economy rebounded accordingly. The PRC is the only major world economy that delivered a GDP growth rate of 2.3% for 2020.

In response to the change in market conditions, China Weaving Materials Holdings Limited (the "**Company**") and its subsidiaries (the "**Group**") has adjusted its product mix and shifted its emphasis to mass market products which were generally geared to downstream customers engaged in the PRC domestic market. The Group took advantage of the rebound of the domestic textile market in the second half, particularly, the fourth quarter of 2020 and sold substantial amount of its inventory of finished goods at favourable prices. Despite the revenue of the Group decreased by 20.9% to approximately RMB1,421.1 million for the year ended 31 December 2020 as compared to RMB1,796.4 million for the year ended 31 December 2019, the gross profit and the profit attributable to the owners of the Company for the year ended 31 December 2020 were approximately RMB143.2 million and approximately RMB62.8 million respectively. The Board has recommended the payment of a dividend of HK2.0 cents per share ("**the Final Dividend**") of the Company in respect of the year ended 31 December 2020 to the shareholders of the Company (the "**Shareholders**").

The rolling out of vaccination programs brought hope for containment of the Pandemic in 2021. However, the risk of new variants of the virus and the geopolitical uncertainty that prevailed during 2020 remain a threat to economic recovery. The Group will continue to closely monitor the market conditions and take necessary measures to adjust its production capacities, product mix and pricing strategy. The Group will continue to emphasize industrial safety and seek improvement in efficiency in the production process by means of automation. The Group will continue to aim at optimal production capacities while keeping an eye on the sales and inventory levels. Taking into account the benefits from the enlarged product portfolio and the economies of scale, the Group is confident about its long term future. The Group believes it is well positioned to take advantage of any positive outlook in the textile industry given its scale of production, strong brand recognition and professional management.

Management Discussion and Analysis

MARKET OVERVIEW

In the first half of 2020, the Pandemic had dealt a serious blow to the global economy, driving it into the most serious recession since the Second World War. There were signs of improvements in the second quarter after the deployment of monetary and relief measures by various governments. The GDP of the US and the EU recorded a strong rebound of around 33.4% and 11.6% for the third quarter respectively. However, for the full year of 2020, the GDP of the US and the EU still suffered contraction of 3.5% and 6.2% respectively. The government of the PRC has been able to contain the Pandemic in the second quarter of 2020 and its economy rebounded accordingly. The PRC is the only major world economy that delivered the GDP growth rate of 2.3% for the full year of 2020.

The Pandemic has hugely affected the demand for crude oil as governments around the world imposed travel restrictions and various quarantine measures in order to contain the Pandemic. The international crude oil futures price dropped from around US\$60 per barrel at the end of 2019 to a negative value in April 2020. It rebounded to around US\$40 per barrel in June 2020 and then hovered at that level for most of the second half of 2020. The downward swing in crude oil price in the first half of 2020 has pushed down the prices of oil related downstream products, including raw materials for polyester yarn products. Due to lower raw material prices, selling prices of polyester related yarn products have been under pressure in the first half of 2020. Fortunately, the recovery of crude oil price in the second half of 2020 provided an upward push for the prices of oil related downstream products, including raw materials for polyester yarn products. Hence, the upward price trend of raw materials contributed to the increase in the selling prices of polyester related yarn products in the second half of 2020 accordingly.

The international cotton prices dropped from around US70 cents per pound at the end of 2019 to below US50 cents per pound at the end of the first quarter of 2020 and steadily climbed back to around US80 cents per pound at the end of 2020. The domestic cotton prices in the PRC have been trading at a similar pattern with that of international cotton. The PRC domestic cotton prices dropped from around RMB13,500 per tonne at the end of 2019 to around RMB11,000 per tonne around the end of the first quarter of 2020 and steadily climbed back to around RMB14,500 per tonne at the end of 2020. The PRC government has maintained the policies of collection of cotton reserve, direct subsidy to cotton farmers and orderly auction of cotton reserves. These policies did not have any significant effect on the prices of PRC domestic cotton.

In the first quarter of 2020, the Pandemic prevention and control measures taken by the PRC government proved to be effective and the Pandemic has been under control in the second quarter and resulted in a rebound of the GDP. The recovery of the economy in the PRC has accelerated during the third and fourth quarters with growth rates of 4.9% and 6.5% respectively. Europe, the US and Latin America experienced major outbreak of the Pandemic around the end of the first quarter. The infection levels appeared to have peaked by the end of 2020 in those areas but still remained high in the first quarter of 2021. The development of multiple vaccines brings optimism about the future. However, there is clearly still some time before life can be back to normal. Recovery will therefore take longer in these economies, which will experience growth more likely later in 2021.

Management Discussion and Analysis

BUSINESS REVIEW

The sales volume of yarn products of the Group decreased by 9.8% from approximately 128,808 tonnes for the year ended 31 December 2019 to approximately 116,242 tonnes for the year ended 31 December 2020. The decrease in sales volume was mainly due to the adverse market conditions caused by the Pandemic in the first half of the year. The production volume of yarn products of the Group decreased by 7.7% from approximately 123,528 tonnes for the year ended 31 December 2019 to approximately 114,032 tonnes for the year ended 31 December 2020. The decrease in the production volume was mainly due to the delay in resumption of production after the Chinese New Year Holiday, as a result of the public health emergency and travel restriction measures undertaken by the PRC government in the first quarter of 2020 in order to contain the spread of the Pandemic. The revenue of the yarn products of the Group decreased by 23.1% to approximately RMB1,297.9 million for the year ended 31 December 2020 as compared to RMB1,687.2 million for the year ended 31 December 2019. The gross profit and the profit attributable to the owners of the Company for the year ended 31 December 2020 were approximately RMB143.2 million and approximately RMB62.8 million respectively. In response to the change in market conditions, the Group has adjusted its product mix and shifted its emphasis to mass market products which were generally geared to downstream customers engaged in the PRC domestic market.

The Group's subsidiary company, Jiangxi Xinyuan Special Fibres Company Limited ("**Xinyuan**") is engaged in the manufacture and trading of polyester staple fibres ("**PSF**") which are one of the basic raw materials of the Group for the production of polyester yarns. The sales volume of PSF increased by 62.9% from approximately 21,808 tonnes for the year ended 31 December 2019 to approximately 35,534 tonnes for the year ended 31 December 2020. The production volume of PSF decreased by 3.2% from approximately 29,358 tonnes for the year ended 31 December 2019 to approximately 28,413 tonnes for the year ended 31 December 2020. The results of Xinyuan improved significantly in 2020. The profit for the year ended 31 December 2020 of Xinyuan was approximately RMB0.5 million as compared to a loss of RMB71.8 million for the year ended 31 December 2019 which included impairment losses of approximately RMB44.5 million. The significant improvement was due to: (i) improvement in market conditions in the second half of 2020 as a result of rising prices of crude oil and related downstream products, including PSF; (ii) improvement in PSF quality by shifting of production materials from recycled plastic chips to chips manufactured directly from petroleum by-products; and (iii) reversal of impairment losses of approximately RMB5.3 million.

The Pandemic has dealt a very serious economic blow to the US and EU areas in the second quarter of 2020 and the major export markets for the PRC apparel industries were seriously hammered. On the other hand, the PRC has been able to contain the Pandemic in the second quarter and the economy rebounded and picked up growth momentum in the third and fourth quarters. The improvement in domestic market consumptions, including apparel consumption, in the PRC in the second half of 2020 was strong. The increased demand by the downstream consumers, a relative low level of inventory in the textile industry resulting from the Pandemic in the first half of the year and an upward price trend of yarn products driven by increases in raw materials prices have contributed to a booming market for yarn products in the second half of 2020. The demand for yarn products and prices of yarn products have been increasing in general in the second half of 2020, particularly in the fourth quarter.

Management Discussion and Analysis

FINANCIAL REVIEW

Revenue

Revenue of the Group for the year ended 31 December 2020 was approximately RMB1,421.1 million, representing a decrease of approximately RMB375.3 million, or 20.9%, as compared to last year. The analysis of the sales of the Group's products is as below:

The decrease in the revenue of the Group for the year ended 31 December 2020 was mainly attributable to the decrease in the sales volume of yarns products from 128,808 tonnes for the year ended 31 December 2019 to 116,242 tonnes for the year ended 31 December 2020 and decrease in the average selling prices of yarns products. The average selling price of yarn products of the Group decreased 14.7% from approximately RMB13,089 per tonne for the year ended 31 December 2019 to approximately RMB11,165 per tonne for the year ended 31 December 2020. The decrease in average selling prices of yarn products was mainly due to the downward positive correlation between the selling prices of yarn products and the prices of raw materials. The average prices of raw materials were lower in 2020 than that in 2019.

Gross Profit and Gross Profit Margin

Gross profit of the Group increased from approximately RMB116.1 million for the year ended 31 December 2019 to approximately RMB143.2 million for the year ended 31 December 2020. The gross profit margin of the Group increased from approximately 6.5% for the year ended 31 December 2019 to approximately 10.1% for the year ended 31 December 2020. The decrease in the average cost of products per tonne was much higher than the decrease in average selling price of products per tonne. The domestic economy of the PRC rebounded in the second quarter and picked up its momentum in the third and fourth quarters of 2020. The improvement in the domestic consumption market, including apparel consumption, was strong in the second half of 2020. This has improved the market conditions for yarn products generally.

Management Discussion and Analysis

Other Income

Other income of the Group slightly increased from approximately RMB28.6 million for the year ended 31 December 2019 to approximately RMB29.2 million for the year ended 31 December 2020, representing an increase of approximately RMB0.6 million or 2.1%.

Other Gains and Losses

Other gains of the Group increased from approximately RMB0.3 million for the year ended 31 December 2019 to approximately RMB3.5 million for the year ended 31 December 2020, representing an increase of approximately RMB3.2 million or 10.7 times. The increase in other gains was mainly due to net foreign exchange gains.

Distribution and Selling Expenses

Distribution and selling expenses of the Group decreased from approximately RMB28.4 million for the year ended 31 December 2019 to approximately RMB26.5 million for the year ended 31 December 2020, representing a decrease of approximately RMB1.9 million or 6.7%. The decrease in distribution and selling expenses was mainly due to the decrease in sales volume. Distribution and selling expenses as a percentage of revenue of the Group was approximately 1.9% for the year ended 31 December 2020 (year ended 31 December 2019: 1.6%).

Administrative Expenses

Administrative expenses of the Group decreased from approximately RMB55.6 million for the year ended 31 December 2019 to approximately RMB49.2 million for the year ended 31 December 2020, representing a decrease of approximately RMB6.4 million or 11.5%. The decrease in administrative expenses was mainly due to the waiver of certain government taxes and levies as part of the relief measures to local business deployed by the local government in response to the Pandemic. Administrative expenses as a percentage of revenue of the Group was approximately 3.5% for the year ended 31 December 2020 (year ended 31 December 2019: 3.1%).

Finance Costs

Finance costs of the Group decreased from approximately RMB32.7 million for the year ended 31 December 2019 to approximately RMB29.4 million for the year ended 31 December 2020, representing a decrease of 10.1% or approximately RMB3.3 million. The decrease in the Group's finance costs was mainly due to lower interest rates as a result of the lowering of the loan prime rate in the PRC in the first half of 2020 and the full repayment of an entrusted loan in 2020.

Income Tax Expense

The Group's income tax expense for the year ended 31 December 2020 was approximately RMB13.2 million, as compared to an income tax expense of approximately RMB4.1 million for 2019. The Group's effective income tax rate for the year ended 31 December 2020 was approximately 17.4%.

Management Discussion and Analysis

Profit/(Loss) attributable to Owners of the Company and Net Profit/(Loss) Margin

Profit attributable to owners of the Company for the year ended 31 December 2020 was approximately RMB62.8 million as compared to a loss attributable to owners of the Company of approximately RMB1.4 million for the year ended 31 December 2019. The net profit margin of the Group for the year ended 31 December 2020 was approximately 4.4% as compared with a net loss margin of approximately 0.1% for the year ended 31 December 2019. The increase in profit attributable to owners of the Company was mainly due to the increase in gross profit and reversal of impairment losses of approximately RMB5.3 million. The loss attributable to owners of the Company for the year ended 31 December 2019 was mainly due to decrease in gross profit and impairment losses of approximately RMB44.5 million.

Earnings/(Loss) per Share

The basic earnings per share of the Company for the year ended 31 December 2020 was approximately RMB5.01 cents as compared with approximately RMB0.11 cents basic loss per share for the year ended 31 December 2019. The increase in earnings per share of the Company was due to the net profit for the year ended 31 December 2020.

Liquidity and Financial Resources

The Group generally finances its operations with internally generated cash flow and facilities provided by its bankers in the PRC and Hong Kong. During the year ended 31 December 2020, the Group generated net cash inflow from operating activities. The Group had cash and bank balances of approximately RMB184.6 million (31 December 2019: RMB135.6 million) and pledged bank deposits of approximately RMB91.0 million (31 December 2019: RMB33.8 million). At 31 December 2020, the Group's cash and bank balances were mainly held in Renminbi.

Capital Structure and Pledge of Assets

The Group's interest-bearing borrowings were mainly made in RMB, HK\$ and US\$. At 31 December 2020, the Group's interest-bearing borrowings amounted to approximately RMB508.9 million (31 December 2019: RMB489.4 million), of which approximately RMB472.4 million (92.8%) (31 December 2019: RMB442.2 million (90.4%)) was repayable within one year or on demand. The Group's banking facilities were secured by its properties, plant and equipment, right-of-use assets and pledged bank deposits with a carrying value of approximately RMB731.6 million in aggregate (31 December 2019: RMB699.1 million).

Gearing Ratio

The gearing ratio of the Group, which is equal to the total of bank borrowings, lease liabilities and bills payable to total assets, was approximately 39.2% at 31 December 2020 (31 December 2019: 38.4%). Net current liabilities and net assets at 31 December 2020 were approximately RMB298.8 million (31 December 2019: RMB399.5 million) and RMB629.2 million (31 December 2019: RMB566.2 million), respectively.

Management Discussion and Analysis

Foreign Exchange Exposure

The Group has certain exposure to foreign currency risk as some of its assets and liabilities are denominated in currencies other than the functional currencies of the Group entities, including HK\$ and US\$. The carrying amounts of the Group's foreign currency denominated monetary assets and liabilities as at 31 December 2020 were approximately RMB6.8 million (31 December 2019: RMB5.3 million) and RMB42.8 million (31 December 2019: RMB48.0 million), respectively. The Group had not used any financial instrument for hedging purposes during the year ended 31 December 2020.

Contingent Liabilities

At 31 December 2020, the Group did not have any significant contingent liabilities.

Employees, Remuneration and Share Option Scheme

At 31 December 2020, the Group had a total of 3,046 employees (31 December 2019: 3,182). Remuneration for employees, including the directors of the Company (the "Directors"), is determined in accordance with performance, professional experiences and the prevailing market practices. The Group's management reviews the Group's employee remuneration policy and arrangement on a regular basis. Apart from pension, discretionary bonus will also be granted to certain employees as awards in accordance with individual performance. The Company had adopted a share option scheme on 3 December 2011, under which the Company may grant options to eligible persons including Directors and employees. No share option has been granted pursuant to the scheme since its adoption.

Significant Investments and Material Acquisitions and Disposal of Subsidiaries

During the year ended 31 December 2020, the Group did not have any significant investments or acquisitions or sales of subsidiaries.

PROSPECTS

Pandemic infection levels remain very high in Europe, the US and Latin America, and new variants of the virus have spread quickly in the first quarter of 2021. While the spike in Pandemic infection rates led to renewed lockdown measures in many places at the beginning of 2021, the development of multiple vaccines gives us hope that the world will return to some form of normality before long. As rolling out of the vaccination programs will take time, the global economy is unlikely to return to normal quickly. The export markets of the textile and apparel enterprises of the PRC would remain very difficult. Nevertheless, Asian countries suffered a much lower Pandemic inflection rate as compared with the western countries. The PRC government has been able to contain the Pandemic in the second quarter of 2020 and reopened the economy. Hence, recoveries in economies of Asian countries are likely to happen soon in 2021. The signing of the Regional Comprehensive Economic Partnership should further boost intra-regional activity across Asia, while the recent political agreement between the EU and the PRC on an investment deal should, once ratified, bolster the already significant two-way investment flows.

With the containment of the Pandemic in the second quarter of 2020 and the implementation of relief measures and policies to promote internal consumptions by the PRC government, the recovery of the economy in the PRC has accelerated during the third and fourth quarters with growth rates of 4.9% and 6.5% respectively. The domestic apparel market of the PRC has benefited from the recovery accordingly.

Management Discussion and Analysis

The recovery of crude oil price in the second half of 2020 provided an upward push for the prices of oil related downstream products, including raw materials for polyester yarn products. The international and domestic cotton prices also recovered in the second half of 2020. The upward price trend of raw materials benefited the selling prices of yarn products in the second half of 2020, particularly in the fourth quarter. The prices of crude oil and international cotton remained high in the first quarter of 2021. If the commodities prices remain steady at a high level, the correlation effect will benefit the textile and yarn product markets accordingly.

The rolling out of vaccination programs brought hope for containment of the Pandemic in 2021. However, the risk of new variant of the virus and the geopolitical uncertainty that prevailed during 2020 remain a threat to economic recovery. In response to the market conditions, the Group has adjusted its product mix and pricing strategy with a view to maximize sales and cash flow. The Group seized the booming market in the fourth quarter of 2020 and sold most of its inventories of finished goods. In the meantime, the Group has accumulated more inventories of raw materials due to a positive view on their prices. The Group will continue to closely monitor the market conditions and take necessary measures to adjust its production capacities, product mix and pricing strategy. The Group will continue to emphasize industrial safety and seek improvement in efficiency in the production process by means of automation. The Group will continue to aim at optimal production capacities while keeping an eye on the sales and inventory levels. Taking into account the benefits from the enlarged product portfolio and the economies of scale, the Group is confident about its long term future. The Group believes it is well positioned to take advantage of any positive outlook in the textile industry given its scale of production, strong brand recognition and professional management.

The Group has complied with the relevant environmental rules and regulations and possesses all the required approval from the relevant Chinese regulators. The subsidiaries of the Company, Jinyuan Textile Co. Ltd. Jiangxi (“**Jiangxi Jinyuan**”) and Jiangxi Huachun Color Spinning Technology Development Co., Ltd. (“**Huachun**”), have obtained the ISO 14001 certificate on environmental management. Jiangxi Jinyuan has over 25,000 square metres of green areas within its factory premises and it has constructed a reservoir to collect rain water for use in the workshop. Jiangxi Jinyuan and Huachun have installed solar panels on the workshop rooftop to provide electricity for workshop lighting. The environment, social and governance report as required by the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) will be issued separately by the Company in due course.

Relationship with Employees

The Directors consider the Group has maintained a harmonious relationship with its employees.

Relationship with Customers and Suppliers

The Group has a large customer base. As at 31 December 2020, the Group had over 1,900 customers. The Group does not rely on a few large customers. During the year ended 31 December 2020, sales to the Group’s five largest customers accounted for 13.3% of the total sales of the Group for 2020 and sales to the largest customer included therein accounted for 3.8% of the total sales of the Group for the same year.

Due to the nature of the raw materials and large quantities required by the Group, there are not too many raw materials suppliers with sufficient scale that could cater for the requirement of the Group. As at 31 December 2020, the Group had around 60 major suppliers of raw materials, production equipment and production accessories. Purchases from the Group’s five largest suppliers accounted for 51.1% of the total purchases of the Group for the year ended 31 December 2020 and purchases from the Group’s largest supplier included therein accounted for 17.9% of the total purchases of the Group for the same year. The Directors consider the Group has maintained a harmonious business relationship with its suppliers.

The Group communicates regularly with its customers and suppliers and carries out reciprocal site visits to understand each other’s requirements and collect market intelligence.

The Board has recommend the payment of the Final Dividend of HK2.0 cents per ordinary share of the Company in respect of the year ended 31 December 2020.

SHARE OPTION SCHEME

The Scheme became effective on 22 December 2011 and, unless otherwise cancelled or amended, will remain in force for 10 years from 22 December 2011. The total number of Shares available for issue under the Scheme and any other share option scheme of the Group must not in aggregate exceed 10% of the total number of Shares in issue immediately following completion of the offer of the Hong Kong Offer Shares for subscription by the public in Hong Kong and the conditional placing by the international underwriters of the international placing shares, being 100,000,000 Shares, representing approximately 7.98% of the issued share capital of the Company as at the date of this report. Subject to the issue of a circular by the Company and the approval of the Shareholders in general meeting and/or such other requirements prescribed under the Listing Rules from time to time, the Board may:

- (i) renew this limit at any time to 10% of the Shares in issue as at the date of the approval by the Shareholders in general meeting; and/or
- (ii) grant options beyond the 10% limit to eligible participants specifically identified by the Board.

The terms of reference of the Board Committees are posted on the websites of the Company and the Stock Exchange. The Board Committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances, at the Company’s expenses.

Remuneration Committee

A remuneration committee was established by the Company on 3 December 2011 (the “**Remuneration Committee**”) with written terms of reference in compliance with the CG Code. The primary duties of the Remuneration Committee include reviewing and determining the terms of remuneration packages, bonuses and other compensation payable to the Directors and members of senior management of the Group. Mr. Xu Yiliang, an independent non-executive Director, is the chairman of the Remuneration Committee. The other members are Ms. Zhang Baixiang and Mr. Li Guoxing, who are also independent non-executive Directors, and Mr. Zheng Hong, the non-executive Director.

During the year ended 31 December 2020, two meetings were held by the Remuneration Committee. The Remuneration Committee reviewed and approved the remuneration packages of the Directors and senior management.

While all Board appointments will continue to be made on a merit basis, the Company will ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the needs of the Company’s business. Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, experience (professional or otherwise), skills and knowledge. The Board will consider setting measurable objectives for achieving diversity on the Board at appropriate time.

Dividend Policy

The Company has adopted a dividend policy under which, in proposing dividends, the Company shall maintain adequate cash reserves for meeting its working capital requirements and strike a balance between future growth and rewarding the Shareholders. The Company does not have any pre-determined payout ratio. The Board shall consider the following factors in proposing dividends: financial results and positions; cash flow position; gearing ratio, credit facilities and indebtedness level; business conditions and strategies; future operations and income; capital requirements and budgets; interests of the Shareholders; any restrictions on payment of dividends; and any other factor that the Board deems relevant. The Company may declare and pay dividends by way of cash or scrip or by other means that the Board considers appropriate.

D. FINANCIAL REPORTING, RISK MANAGEMENT AND INTERNAL CONTROLS

Financial Reporting

The Directors acknowledge their responsibility for preparing the Group's financial statements which give a true and fair view and are in accordance with appropriate International Financial Reporting Standards. Appropriate accounting policies are being selected and applied consistently.

The Group continues to adopt the going concern basis in preparing its consolidated financial statements. As of 31 December 2020, the Group's current liabilities exceeded its current assets by approximately RMB298,777,000. The condition indicates the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern. The Directors have reviewed the Group's cash flow projection in which the level of the demand of the Group's products and the potential implications of the Pandemic have been considered. The projection covers a period of 12 months from 31 December 2020. The Directors have a reasonable expectation that, after taking into account the following plans and measures, the Group will have sufficient working capital to meet its financial obligations as and when they fall due within the next 12 months:

- (a) The Group can successfully obtain its bankers' approval for rollover of its short term bank borrowings. Up to the date of the consolidated financial statements authorised for issue, certain bankers have agreed to renew the Group's bank borrowings amounting to approximately RMB93,000,000 currently included in current liabilities at 31 December 2020.
- (b) The Group will also continue to seek for further financing. Certain existing property, plant and equipment and right-of-use assets can be offered as security for further financing.
- (c) The Group is closely monitoring the latest development of the Pandemic and will continue to assess the impact of the Pandemic, as well as any change in government policy, on the Group's operations from time to time and adjust its production and sales strategies for its business to generate sufficient operating cash flows.

Having taken into account the above plans and measures, the Directors are of the opinion that the Group should be able to operate within the level of its current banking facilities and will have sufficient working capital to meet its financial obligations as and when they fall due within the next 12 months. Accordingly, the consolidated financial statements have been prepared on a going concern basis.

The responsibilities of the external auditor with respect to the audit of the consolidated financial statements are set out in the Independent Auditor's Report on pages 34 to 40.

Auditor's Remuneration

During the year ended 31 December 2020, the Group has incurred auditor's remuneration in respect of audit and non-audit services of approximately RMB923,000 and RMB229,000, respectively, which was paid or payable to the Company's auditor, RSM Hong Kong.

Risk Management and Internal Control

The Group's risk management and internal control systems are designed to facilitate the effectiveness and efficiency of operations, safeguard assets against unauthorised use and disposition, ensure the maintenance of proper accounting records and the truth and fairness of the financial statements, and ensure compliance with relevant legislation and regulations. The systems are implemented to minimise risks to which the Group is exposed and can provide reasonable, but not absolute, assurance against material misstatement or loss rather than the elimination of risks associated with its business activities.

The Board acknowledges that it is responsible for maintaining adequate systems of risk management and internal control for the Group and the Directors had conducted annual review of their effectiveness during the year through the Audit Committee. Such review covered all material controls, including financial, operational and compliance controls and risk management functions. The Board is satisfied that the Group's risk management and internal control systems, including financial, operational and compliance controls and risk management functions as appropriate to the Group, have been put in place and that no significant areas of improvement which are required to be brought to the attention of the Audit Committee have been revealed. The Board considers the risk management and internal control systems effective and adequate.

E. COMMUNICATIONS WITH SHAREHOLDERS AND SHAREHOLDERS' RIGHT

The Board recognises the importance of effective communication with the Shareholders and investors. The Company shall arrange notices of meetings and circulars containing details of proposed resolutions to be sent to the Shareholders no less than 20 business days before the meetings. At general meetings, separate resolutions are proposed on each substantial issue, including the election of individual Directors.

The Board always ensures that Shareholders' and investors' views are heard and understood, and welcomes their questions and concerns relating to the Group's management and governance. The Company's website provides email address and telephone number to enable the Shareholders to make any enquiries and concerns to the Board. Shareholders and investors may also at any time send their enquiries and concerns to the Board by addressing to the Company Secretary by post or by email. The contact details are set out in the "Corporate Information" section of this annual report.

Procedures for Shareholders to Convene an Extraordinary General Meeting and to put forward Proposals at General Meetings

Pursuant to Article 58 of the Articles, any one or more Members (as defined therein) holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition to the Board or the Company Secretary, to require an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty-one (21) days of such deposit the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

Procedures for Proposing a Person for Election as a Director

Pursuant to Article 85 of the Articles, no person other than a Director retiring at the meeting shall, unless recommended by the Directors for election, be eligible for election as a Director at any general meeting unless a Notice (as defined therein) signed by a Member (as defined therein) (other than the person to be proposed) duly qualified to attend and vote at the meeting for which such notice is given of his intention to propose such person for election and also a Notice signed by the person to be proposed of his willingness to be elected shall have been lodged at the head office or at the Registration Office provided that the minimum length of the period, during which such Notice(s) are given, shall be at least seven (7) days and that (if the Notices are submitted after the despatch of the notice of the general meeting appointed for such election) the period for lodgment of such Notice(s) shall commence on the day after the despatch of the notice of the general meeting appointed for such election and end no later than seven (7) days prior to the date of such general meeting.

1. GENERAL INFORMATION

China Weaving Materials Holdings Limited (the “**Company**”) was incorporated in the Cayman Islands on 4 May 2011 and its shares are listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”). The registered office of the Company is at Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands and the principal place of business of the Company is at Fengtian Economic Development Zone of Fengxin County, Yichun City, Jiangxi Province, the People’s Republic of China (“**PRC**”).

The Company together with its subsidiaries (collectively referred to as the “**Group**”) are principally engaged in the business of manufacturing and trading of yarn products and related raw materials.

These consolidated financial statements for the year ended 31 December 2020 are presented in Renminbi (“**RMB**”), which is the same as the functional currency of the Company.

2. BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with all applicable International Financial Reporting Standards (“**IFRSs**”) issued by the International Accounting Standards Board (the “**IASB**”). IFRSs comprise individual International Financial Reporting Standards (“**IFRS**”); International Accounting Standards (“**IAS**”); and Interpretations. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange and with the disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622). Significant accounting policies adopted by the Group are disclosed below.

The IASB has issued certain new and revised IFRSs that are first effective for the current accounting period of the Group. Note 3 provides information of these developments which are relevant to the Group’s operations. The application of these developments did not have material impact on the Group.

2. BASIS OF PREPARATION (Continued)

As of 31 December 2020, the Group's current liabilities exceeded its current assets by approximately RMB298,777,000. The condition indicates the existence of a material uncertainty which may cast significant doubt on the Group's ability to continue as a going concern. The directors have reviewed the Group's cash flow projections in which the level of the demand of the Group's products and the potential implications of COVID-19 have been considered. The projection covers a period of 12 months from 31 December 2020. The directors have a reasonable expectation that, after taking into account the following plans and measures, the Group will have sufficient working capital to meet its financial obligations as and when they fall due within the next 12 months:

- (a) The Group can successfully obtain its bankers' approval for rollover of its short term bank borrowings. Up to the date of the consolidated financial statements were authorised for issue, certain bankers have agreed to renew the Group's bank borrowings amounting to approximately RMB93,000,000 currently included in current liabilities at 31 December 2020.
- (b) The Group will also continue to seek for further financing. Certain existing property, plant and equipment and right-of-use assets can be offered as security for further financing.
- (c) In the light of the COVID-19 pandemic, the Group is closely monitoring the latest developments and will continue to assess the impact of the COVID-19 pandemic, as well as any change in government policy, on the Group's operations from time to time and adjust its production and sales strategies for its business to generate sufficient operating cash flows.

Having taken into account the above plans and measures, the directors are of the opinion that the Group should be able to operate within the level of its current banking facilities and will have sufficient working capital to meet its financial obligations as and when they fall due within the next 12 months. Accordingly, the consolidated financial statements have been prepared on a going concern basis.

Notwithstanding the above, significant uncertainties exist. The current economic conditions continue to create uncertainty particularly over the level of demand for the Group's products and the availability of bank finance for the foreseeable future.

Should the Group be unable to continue as a going concern, adjustments would have to be made to restate the values of the assets to their recoverable amounts, to provide for any further liabilities which might arise and to classify non-current assets and liabilities as current assets and liabilities respectively. The effects of these potential adjustments have not been reflected in the consolidated financial statements.

4. SIGNIFICANT ACCOUNTING POLICIES

These consolidated financial statements have been prepared under the historical cost convention, unless mentioned otherwise in the accounting policies below (e.g. certain financial instruments that are measured at fair value).

The preparation of consolidated financial statements in conformity with IFRSs requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in Note 5.

The significant accounting policies applied in the preparation of these consolidated financial statements are set out below.

(a) Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date the control ceases.

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill and any accumulated foreign currency translation reserve relating to that subsidiary.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests represent the equity in subsidiaries not attributable, directly or indirectly, to the Company. Non-controlling interests are presented in the consolidated statement of financial position and consolidated statement of changes in equity within equity. Non-controlling interests are presented in the consolidated statement of profit or loss and other comprehensive income as an allocation of profit or loss and total comprehensive income for the year between the non-controlling shareholders and owners of the Company.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling shareholders even if this results in the non-controlling interests having a deficit balance.

(a) Consolidation (Continued)

Changes in the Company's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions (i.e. transactions with owners in their capacity as owners). The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment loss.

(b) Business combination and goodwill

The acquisition method is used to account for the acquisition of a subsidiary in a business combination. The consideration transferred in a business combination is measured at the acquisition-date fair value of the assets given, equity instruments issued, liabilities incurred and any contingent consideration. Acquisition-related costs are recognised as expenses in the periods in which the costs are incurred and the services are received. Identifiable assets and liabilities of the subsidiary in the acquisition are measured at their acquisition-date fair values.

The excess of the sum of the consideration transferred over the Group's share of the net fair value of the subsidiary's identifiable assets and liabilities is recorded as goodwill. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the sum of the consideration transferred is recognised in consolidated profit or loss as a gain on bargain purchase which is attributed to the Group.

In a business combination achieved in stages, the previously held equity interest in the subsidiary is remeasured at its acquisition-date fair value and the resulting gain or loss is recognised in consolidated profit or loss. The fair value is added to the sum of the consideration transferred in a business combination to calculate the goodwill.

The non-controlling interests in the subsidiary are initially measured at the non-controlling shareholders' proportionate share of the net fair value of the subsidiary's identifiable assets and liabilities at the acquisition date.

After initial recognition, goodwill is measured at cost less accumulated impairment losses. For the purpose of impairment testing, goodwill acquired in a business combination is allocated to each of the cash-generating units ("CGUs") or groups of CGUs that is expected to benefit from the synergies of the combination. Each unit or group of units to which the goodwill is allocated represents the lowest level within the Group at which the goodwill is monitored for internal management purposes. Goodwill impairment reviews are undertaken annually, or more frequently if events or changes in circumstances indicate a potential impairment. The carrying value of the CGU containing the goodwill is compared to its recoverable amount, which is the higher of value in use and the fair value less costs of disposal. Any impairment is recognised immediately as an expense and is not subsequently reversed.

(c) Foreign currency translation

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "**functional currency**"). The consolidated financial statements are presented in RMB, which is the Company's functional and presentation currency.

(ii) Transactions and balances in each entity's financial statements

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

Non-monetary items that are measured at fair value in foreign currencies are translated using the exchange rates at the dates when the fair values are determined.

When a gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is recognised in other comprehensive income. When a gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is recognised in profit or loss.

(d) Property, plant and equipment

Property, plant and equipment are held for use in the production or supply of goods, or for administrative purposes (other than properties under construction as described below), are stated in the consolidated statement of financial position at cost, less subsequent accumulated depreciation and subsequent accumulated impairment losses, if any.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost less their residual values over the estimated useful lives on a straight-line basis. The principal useful lives are as follows:

Buildings	10 - 30 years
Leasehold improvement	3 years
Plant and machinery	1 - 20 years
Office equipment	3 - 10 years
Motor vehicles	4 - 10 years

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting period.

Construction in progress represents buildings under construction and plant and equipment pending installation, and is stated at cost less impairment losses, if any. Depreciation begins when the relevant assets are available for use.

The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

(e) Leases

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

(i) The Group as a lessee

Where the contract contains lease component(s) and non-lease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

At the lease commencement date, the Group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the Group enters into a lease in respect of a low-value asset, the Group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses.

Right-of-use assets in which the Group is reasonably certain to obtain ownership of the underlying leased assets at the end of the lease term are depreciated from commencement date to the end of the useful life. Otherwise, right-of-use assets are depreciated on a straight-line basis over the shorter of its estimated useful life and the lease term.

(i) The Group as a lessee (Continued)

When the Group obtains ownership of the underlying leased assets at the end of the lease term, upon exercising purchase options, the cost of the relevant right-of-use assets and the related accumulated depreciation and impairment losses, if any, are transferred to property, plant and equipment.

Refundable rental deposits paid are accounted under IFRS 9 Financial Instruments (“IFRS 9”) and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

The lease liability is remeasured when there is a change in future lease payments arising from a change in an index or rate, or there is a change in the Group’s estimate of the amount expected to be payable under a residual value guarantee, or there is a change arising from the reassessment of whether the Group will be reasonably certain to exercise a purchase, extension or termination option. When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the right-of-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

The lease liability is also remeasured when there is a change in the scope of a lease or the consideration for a lease that is not originally provided for in the lease contract that is not accounted for as a separate lease. In this case the lease liability is remeasured based on the revised lease payments and lease term using a revised discount rate at the effective date of the modification.

(ii) The Group as a lessor

When the Group acts as a lessor, it determines at lease inception whether each lease is a finance lease or an operating lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to the ownership of an underlying assets to the lessee. If this is not the case, the lease is classified as an operating lease.

(f) Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out basis. The cost of finished goods and work in progress comprises raw materials, direct labour and an appropriate proportion of all production overhead expenditure and where appropriate, subcontracting charges. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

(g) Contract liabilities

A contract liability is recognised when the customer pays consideration before the Group recognises the related revenue. A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised.

When the contract includes a significant financing component, the contract balance includes interest accrued under the effective interest method.

(h) Recognition and derecognition of financial instruments

Financial assets and financial liabilities are recognised in the consolidated statement of financial position when the Group becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss ("FVTPL")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss.

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss.

(i) Financial assets

All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace. All recognised financial assets are measured subsequently in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

Debt instruments

Debt instruments held by the Group are classified into one of the following measurement categories:

- amortised cost, if the instrument is held for the collection of contractual cash flows which represent solely payments of principal and interest. Interest income from the instrument is calculated using the effective interest method. Typically trade receivables, other receivables, cash and bank balances are classified in this category.
- Fair value through other comprehensive income (“**FVTOCI**”) – recycling, if the contractual cash flows of the instrument comprise solely payments of principal and interest and the investment is held within a business model whose objective is achieved by both the collection of contractual cash flows and sale. Changes in fair value are recognised in other comprehensive income, except for the recognition in profit or loss of expected credit losses (“**ECL**”), interest income (calculated using the effective interest method) and foreign exchange gains and losses. When the instrument is derecognised, the amount accumulated in other comprehensive income is recycled from equity to profit or loss.
- FVTPL if the instrument does not meet the criteria for being measured at amortised cost or FVTOCI (recycling). Changes in the fair value of the instrument (including interest) are recognised in profit or loss. This category includes bills receivable.

(j) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset.

Receivables are stated at amortised cost using the effective interest method less allowance for credit losses.

(k) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of change in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flows. Cash and cash equivalents are assessed for the ECL.

(l) Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under IFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

(m) Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred, and subsequently measured at amortised cost using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

(n) Financial guarantee contract

Financial guarantee contracts are recognised as a financial liability at the time the guarantee is issued. The liability is initially measured at fair value and subsequently at the higher of:

- the amount determined in accordance with the ECL model under IFRS 9; and
- the amount initially recognised less, where appropriate, the cumulative amount of income recognised in accordance with the principles of IFRS 15 Revenue from Contracts with Customers ("IFRS 15").

The fair value of financial guarantees is determined based on the present value of the difference in cash flows between the contractual payments required under the debt instrument and the payments that would be required without the guarantee, or the estimated amount that would be payable to a third party for assuming the obligations.

Where guarantees in relation to loans or other payables of associates are provided for no compensation, the fair values are accounted for as contributions and recognised as part of the cost of the investment.

(o) Trade and other payables

Trade and other payables are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

(p) Equity instruments

An equity instrument is any contract that evidence a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

(q) Revenue and other income

Revenue is recognised when control over a product is transferred to the customer, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Revenue from the sales of manufactured goods and trading of raw materials is recognised when control of the goods has transferred, being when the goods have been shipped to the customer's specific location (delivery). Following delivery, the customer has full discretion over the manner of distribution and price to sell the goods, has the primary responsibility when on selling the goods and bears the risks of obsolescence and loss in relation to the goods. A receivable is recognised by the Group when the goods are delivered to the customer as this represents the point in time at which the right to consideration becomes unconditional, as only the passage of time is required before payment is due.

Interest income is recognised as it accrues using the effective interest method. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset.

Rental income receivable under operating leases is recognised in profit or loss in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the use of the leased asset.

(r) Employee benefits

(i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(ii) Retirement benefits schemes

The Group operates the below post-employment schemes which are defined contribution pension plans:

The Group operates a mandatory provident fund scheme (the “**MPF Scheme**”) under the Hong Kong Mandatory Provident Fund Schemes Ordinance (the “**Ordinance**”) for all qualifying employees in Hong Kong. The Group’s contributions to the MPF Scheme are calculated at 5% of the salaries and wages subject to a monthly maximum amount specified in the Ordinance per employee and vest fully with employees when contributed into the MPF Scheme.

The employees of the Group’s subsidiaries established in the PRC are members of a central pension scheme operated by the local municipal government. These subsidiaries are required to contribute certain percentage of the employees’ basic salaries and wages to the central pension scheme to fund the retirement benefits. The local municipal government undertakes to assume the retirement benefit obligations of all existing and future retired employees of these subsidiaries. The only obligation of these subsidiaries with respect to the central pension scheme is to meet the required contributions under the scheme.

The retirement benefit costs charged to profit or loss represent contributions payable by the Group to the funds.

(iii) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits, and when the Group recognises restructuring costs and involves the payment of termination benefits.

(s) Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

To the extent that funds are borrowed generally and used for the purpose of obtaining a qualifying asset, the amount of borrowing costs eligible for capitalisation is determined by applying a capitalisation rate to the expenditures on that asset. The capitalisation rate is the weighted average of the borrowing costs applicable to the borrowings of the Group that are outstanding during the period, other than borrowings made specifically for the purpose of obtaining a qualifying asset. Any specific borrowing that remain outstanding after the related asset is ready for its intended use or sale is included in the general borrowing pool for calculation of capitalisation rate on general borrowings.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

(t) Government grants

A government grant is recognised when there is reasonable assurance that the Group will comply with the conditions attaching to it and that the grant will be received.

Government grants that become receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

Government grants relating to the purchase of assets are recorded as deferred income and recognised in profit or loss on a straight-line basis over the useful lives of the related assets.

(u) Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

(u) Taxation (Continued)

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

(v) Impairment of non-financial assets

Intangible assets that have an indefinite useful life or that are not yet available for use are reviewed for impairment annually and whenever events or changes in circumstances indicate the carrying amount may not be recoverable.

The carrying amounts of other non-financial assets are reviewed at each reporting date for indications of impairment and where an asset is impaired, it is written down as an expense through the consolidated statement of profit or loss to its estimated recoverable amount. The recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. If this is the case, recoverable amount is determined for the CGU to which the asset belongs. Recoverable amount is the higher of value in use and the fair value less costs of disposal of the individual asset or the CGU.

Value in use is the present value of the estimated future cash flows of the asset/CGU. Present values are computed using pre-tax discount rates that reflect the time value of money and the risks specific to the asset/CGU whose impairment is being measured.

Impairment losses for CGUs are allocated first against the goodwill of the unit and then pro rata amongst the other assets of the CGUs. The carrying amount of an asset is not reduced below the highest of its fair value less cost of disposal (if measurable); its value in use (if determinable); and zero. If this results in an amount being allocated to an asset less than its pro-rata share of the impairment loss, the amount of the impairment loss that would otherwise have been allocated to the asset is allocated pro-rata amongst the other assets of the CGU. Subsequent increases in the recoverable amount caused by changes in estimates are credited to profit or loss to the extent that they reverse the impairment.

(w) Impairment of financial assets

The Group recognises a loss allowance for ECL on its assets carried at amortised cost, such as trade and other receivables. The amount of ECL is updated at each reporting date to reflect changes in credit risk since initial recognition of the respective financial instrument.

The Group always recognises lifetime ECL for trade receivables. Trade receivables have been grouped based on shared credit risk characteristics. Vast majority of the customers of the Group are involved in clothing or textile industry and located in the PRC. The expected loss rate for the PRC textile industry is a reasonable approximation of the loss rate for trade receivables.

The expected loss rate is based on the industry probability of default and recovery rate for PRC textile industry. The assessment of the expected loss rate is adjusted to reflect current and forward-looking information on macroeconomic factors affecting the ability of the customers to settle the receivables.

For all other financial instruments, the Group recognises lifetime ECL when there has been a significant increase in credit risk since initial recognition. However, if the credit risk on the financial instrument has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to 12-month ECL.

Lifetime ECL represent the ECL that will result from all possible default events over the expected life of a financial instrument. In contrast, 12-month ECL represent the portion of lifetime ECL that are expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

Significant increase in credit risk

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument at the reporting date with the risk of a default occurring on the financial instrument at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. Forward-looking information considered includes the future prospects of the industries in which the Group's debtors operate, obtained from economic expert reports, financial analysts, governmental bodies, relevant think-tanks and other similar organisations, as well as consideration of various external sources of actual and forecast economic information that relate to the Group's core operations.

Significant increase in credit risk (Continued)

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk for a particular financial instrument;
- existing or forecast adverse changes in business, financial or economic conditions that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations;
- an actual or expected significant deterioration in the operating results of the debtor;
- significant increases in credit risk on other financial instruments of the same debtor;
- an actual or expected significant adverse change in the regulatory, economic, or technological environment of the debtor that results in a significant decrease in the debtor's ability to meet its debt obligations.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk on a financial asset has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a financial instrument has not increased significantly since initial recognition if the financial instrument is determined to have low credit risk at the reporting date. A financial instrument is determined to have low credit risk if:

- (i) The financial instrument has a low risk of default,
- (ii) The debtor has a strong capacity to meet its contractual cash flow obligations in the near term, and
- (iii) Adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

The Group considers a financial asset to have low credit risk when the asset has external credit rating of "investment grade" in accordance with the globally understood definition or if an external rating is not available, the asset has an internal rating of "performing". Performing means that the counterparty has a strong financial position and there is no past due amounts.

The Group regularly monitors the effectiveness of the criteria used to identify whether there has been a significant increase in credit risk and revises them as appropriate to ensure that the criteria are capable of identifying significant increase in credit risk before the amount becomes past due.

Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that receivables that meet either of the following criteria are generally not recoverable.

- when there is a breach of financial covenants by the counterparty; or
- information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group).

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Credit-impaired financial assets

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired includes observable data about the following events:

- significant financial difficulty of the issuer or the counterparty;
- a breach of contract, such as a default or past due event;
- the lender(s) of the counterparty, for economic or contractual reasons relating to the counterparty's financial difficulty, having granted to the counterparty a concession(s) that the lender(s) would not otherwise consider;
- it is becoming probable that the counterparty will enter bankruptcy or other financial reorganisation; or
- the disappearance of an active market for that financial asset because of financial difficulties.

Write-off policy

The Group writes off a financial asset when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, including when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over two years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures. Any recoveries made are recognised in profit or loss.

Measurement and recognition of ECL

The measurement of ECL is a function of the probability of default, loss given default (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information as described above. As for the exposure at default, for financial assets, this is represented by the assets' gross carrying amount at the reporting date.

For financial assets, the ECL are estimated as the difference between all contractual cash flows that are due to the Group in accordance with the contract and all the cash flows that the Group expects to receive, discounted at the original effective interest rate.

If the Group has measured the loss allowance for a financial instrument at an amount equal to lifetime ECL in the previous reporting period, but determines at the current reporting date that the conditions for lifetime ECL are no longer met, the Group measures the loss allowance at an amount equal to 12-month ECL at the current reporting date, except for assets for which simplified approach was used.

The Group recognises an impairment gain or loss in profit or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

(x) Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

(y) Events after the reporting period

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period or those that indicate the going concern assumption is not appropriate are adjusting events and are reflected in the consolidated financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

Critical judgements in applying accounting policies

In the process of applying the accounting policies, the directors have made the following judgements that have the most significant effect on the amounts recognised in the consolidated financial statements (apart from those involving estimations, which are dealt with below).

Going concern basis

These consolidated financial statements have been prepared on a going concern basis, the validity of which depends upon the factors considered by the directors as detailed in Note 2.

Key sources of estimation uncertainty

The Group has considered the impact arising from COVID-19 when preparing the consolidated financial statements. Assumptions and estimates are based on circumstances and conditions available when the consolidated financial statements were prepared and, in particular, the Group has assessed that the current market condition as a result of COVID-19 is not a long-term norm. Given the severity, duration and economic consequences of COVID-19 are uncertain, actual impact may differ significantly from the Group's estimates. The Group will remain alert and cautious on the ongoing development of COVID-19 that may cause further volatility and uncertainty in the global financial market, economy and business environment, and will take necessary measures to address the impact arising therefrom.

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

(a) Income taxes

The Group is subject to income taxes in several jurisdictions. Significant estimates are required in determining the provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made. During the year, approximately RMB13,208,000 (2019: RMB4,100,000) of income tax was charged to profit or loss based on the estimated profit from operations.

(b) Impairment assessment of property, plant and equipment and right-of-use assets

Property, plant and equipment and right-of-use assets are stated at costs less accumulated depreciation and subsequent accumulated impairment losses, if any. In determining whether an asset is impaired, the Group has to exercise judgment and make estimation, particularly in assessing: (i) whether an event has occurred or any indicators that may affect the asset value; (ii) whether the carrying value of an asset can be supported by the recoverable amount, in the case of value in use, the net present value of future cash flows which are estimated based upon the continued use of the asset; and (iii) the appropriate key assumptions to be applied in estimating the recoverable amounts including cash flow projections and an appropriate discount rate. When it is not possible to estimate the recoverable amount of an individual asset (including right-of-use assets), the Group estimates the recoverable amount of the CGU to which the assets belong. Changing the assumptions and estimates, including the discount rates or the growth rate in the cash flow projections, could materially affect the recoverable amounts.

Furthermore, the cash flows projections, growth rate and discount rate are subject to higher degree of estimation uncertainties in the current year due to uncertainty on how the COVID-19 pandemic may progress and evolve.

The carrying amount of property, plant and equipment and right-of-use assets at 31 December 2020 were approximately RMB911,698,000 (2019: RMB951,945,000) and RMB74,906,000 (2019: RMB80,668,000) respectively.

(c) Impairment assessment of goodwill

Determining whether goodwill is impaired requires an estimation of the value in use of the CGU to which goodwill has been allocated. The value in use calculation requires the Group to estimate the future cash flows expected to arise from the CGU and a suitable discount rate in order to calculate the present value. Where the actual future cash flows are less than the expected, or change in facts and circumstances which results in downward revision of future cash flows or upward revision of discount rate, a material impairment loss or further impairment loss may arise.

Furthermore, the cash flows projections, growth rate and discount rate are subject to higher degree of estimation uncertainties in the current year due to uncertainty on how the COVID-19 pandemic may progress and evolve.

The carrying amount of goodwill at the end of the reporting period was approximately RMB20,617,000 (2019: RMB20,617,000).

(d) Deferred tax assets

Deferred tax assets are recognised for all unused tax losses and deductible temporary differences to the extent that it is probable that taxable profit will be available against which the losses or deductible temporary differences can be utilised. Significant management estimation is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and level of future taxable profits together with future tax planning strategies. Details of the Group's deferred tax are set out in Note 33.

(e) Net realisable value of inventories

Allowance for inventories is made based on the ageing and estimated net realisable value of inventories. The assessment of the allowance amount involves judgement and estimates. Where the actual outcome in future is different from the original estimate, such difference will impact the carrying value of inventories and allowance charge/write-back in the period in which such estimate has been changed. A reversal of allowance for inventories of approximately RMB2,110,000 was made for the year ended 31 December 2020 (2019: Allowance for inventories of approximately RMB2,372,000 was made).

6. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: foreign currency risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Foreign currency risk

The Group has certain exposure to foreign currency risk as some of its business transactions, assets and liabilities are denominated in currencies other than the functional currencies of the Group entities, including Hong Kong dollars ("HK\$") and United States dollars ("US\$"). The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group monitors its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

At 31 December 2020, if RMB had weakened 5 per cent against US\$ with all other variables held constant, consolidated profit after tax would have been approximately RMB121,000 higher (2019: consolidated loss after tax would have been approximately RMB208,000 higher), arising mainly as a result of the foreign exchange gain on cash and bank balances and pledge bank deposits (2019: foreign exchange loss on other borrowings, trade payables and bills payable) denominated in US\$. If RMB had strengthened 5 per cent against US\$ with all other variables held constant, consolidated profit after tax would have been approximately RMB121,000 lower (2019: consolidated loss after tax would have been approximately RMB208,000 lower), arising mainly as a result of the foreign exchange loss on cash and bank balances and pledged bank deposits (2019: foreign exchange gain on other borrowings, trade payables and bills payable) denominated in US\$.

At 31 December 2020, if RMB had weakened 5 per cent against HK\$ with all other variables held constant, consolidated profit after tax would have been approximately RMB1,581,000 lower (2019: consolidated loss after tax would have been approximately RMB1,547,000 higher), arising mainly as a result of the foreign exchange loss on bank borrowings, lease liabilities and other payables (2019: bank borrowings, lease liabilities and other payables) denominated in HK\$. If RMB had strengthened 5 per cent against HK\$ with all other variables held constant, consolidated profit after tax would have been approximately RMB1,581,000 higher (2019: consolidated loss after tax would have been approximately RMB1,547,000 lower), arising mainly as a result of the foreign exchange gain on bank borrowings, lease liabilities and other payables (2019: bank borrowings, lease liabilities and other payables) denominated in HK\$.

(b) Credit risk

Credit risk is the risk that a counterparty will not meet its obligations under a financial instrument or customer contract, leading to a financial loss. The Group's credit risk is primarily attributable to its trade and other receivables, bills receivable, pledged bank deposits and cash and bank balances.

The Group's exposure to credit risk arising from bills receivable, pledged bank deposit and bank balances is limited because the counterparties are well-established banks in Hong Kong and the PRC. The credit quality of bills receivable, bank deposits and balances has been assessed by reference to external credit ratings or to historical information about the counterparty default rates. The existing counterparties do not have defaults in the past. Therefore, expected credit loss rate is assessed to be close to zero.

Trade receivables

The Group has concentration of credit risk on the Group's trade receivables as 100% (2019: 100%) of the customers are involved in clothing or textile industry and located in the PRC.

In order to minimise the credit risk, the directors have delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up actions are taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual trade debt regularly to ensure that adequate impairment losses are recognised for irrecoverable debts. Depending on the customer's credit worthiness and historical relationship with the Group, the Group may require cash payment before delivery of products.

The Group grants extended credit terms to customers with overall creditworthiness, as determined by its credit assessment. For customers to whom credit terms are extended, the Group assesses a number of factors to determine whether collection from them is reasonably assured, including past transaction history with them and their creditworthiness. In this regard, the directors consider that the Group's credit risk is significantly reduced.

The Group applies the simplified approach to provide for ECL prescribed by IFRS 9, which permits the use of lifetime ECL provision for all trade receivables.

The Group has assessed that the expected loss rate for trade receivables was insignificant. Thus, no loss allowance provision for trade receivables was recognised at 31 December 2020.

(c) Liquidity risk

In preparing the consolidated financial statements, the directors of the Group have given careful consideration to the future liquidity and going concern of the Group in light of the fact that the Group's current liabilities exceeded its current assets by approximately RMB298,777,000 (2019: RMB399,456,000) at 31 December 2020. Up to the date of these consolidated financial statements were authorised for issue, certain banks agreed to renew bank loans amounting to approximately RMB93,000,000. The Group relies on bank borrowings as significant sources of liquidity. The directors are satisfied that the Group will have sufficient financial resources to meet its financial obligations as they fall due for the foreseeable future, after taking into consideration the banking facilities already in place and accordingly, the consolidated financial statements have been prepared on a going concern basis.

The following table details the Group's remaining contractual maturity for its non-derivative financial liabilities. The table has been drawn up based on the undiscounted cash flows of financial liabilities based on the earliest dates on which the Group can be required to pay. The table includes both interest and principal cash flows.

Specifically, for bank and other borrowings and lease liabilities which contain a repayment on demand clause that can be exercised at the banks' sole discretion, the analysis shows the cash outflow based on the earliest period in which the entity can be required to pay, that is if the banks were to invoke its unconditional rights to call the loans with immediate effect.

In making the assessment, internal and external sources of information are considered. These included management's production and sales strategies, the impact of COVID-19 and the mild upward trend in recent market price of polyester staple fibres.

The recoverable amount of the CGU is determined on the basis of the value in use using discounted cash flow method as assessed by independent qualified professional valuer and approved by the directors. The key assumptions for the discounted cash flow method are those regarding the discount rate, growth rate and budgeted EBITDA margin. The discount rate used is pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the CGU. Management determined the EBITDA margin based on past performance and expectations on market development, and the business model the entity undertakes.

The cash flow forecasts are derived from the most recent financial budgets approved by the directors for the next five years with an average EBITDA margin growth rate of 4.67% (2019: 1.28%) and the residual period using the growth rate of 2.6% (2019: 3.0%) which is based on long-term average economic growth rate of the geographical area in which the business of the CGU operates.

The rate used to discount the forecast cash flows from the Group's manufacturing and trading of polyester staple fibres activities is 12.94% (2019: 11.87%).

Based on the value in use calculation, the recoverable amount of the CGU at 31 December 2020 of RMB39,721,000 is higher than the carrying amounts of property, plant and equipment and right-of-use assets belong to the CGU. As a result, a reversal of impairment losses on property, plant and equipment and right-of-use assets (Note 20) amounting to approximately RMB5,158,000 and RMB134,000 respectively were recognised during the year.

This bank borrowing with carrying amount of RMB10,000,000 was classified under current liabilities. The management of Xinyuan notified the bank upon becoming aware of the breach, the bank has issued a waiver letter to waive the financial covenant term of such bank borrowing subsequent to the reporting period. Notwithstanding the above, the directors believe that adequate alternative sources of finance are available to ensure that there is no threat to the continuing operations of Xinyuan.

32. ENTRUSTED LOAN PAYABLE

On 4 December 2018, the Group entered into a two-year entrusted loan agreement with a director - Mr. Zheng Yongxiang and a bank in which Mr. Zheng Yongxiang provided a loan of RMB50,000,000 to the Group through this entrusted bank. The entrusted loan is unsecured and arranged at 6% fixed interest rate per annum. The loan had been fully repaid in the current year.

Based on recommendations of the directors, the Group balances its overall capital structure through the payment of dividends, new capital injection as well as the issue of new debt.

The externally imposed capital requirements for the Group are: (a) in order to maintain its listing on the Stock Exchange it has to have a public float of at least 25% of the shares; and (b) to meet financial covenants attached to the interest-bearing borrowings.

The Group receives a report from the share registrars regularly on substantial share interests showing the non-public float and demonstrates the continuing compliance with the 25% limit throughout the year.

The Group is subject to the maintenance of a specified financial requirement on its consolidated tangible net worth. During the year, the Group complied with the aforesaid financial requirement of its interest-bearing borrowings. Certain subsidiaries of the Company are also subject to the maintenance of specified financial requirements on its debt-asset ratio and current ratio. It is required to contribute certain percentage of their payroll costs to the retirement benefits scheme to fund the benefits. The only obligation of the Group with respect to the retirement benefits scheme is to make the specified contributions.

In addition, the Group operates the MPF Scheme for all qualifying Hong Kong employees in the Group. The assets of the MPF scheme are held separately from those of the Group, in funds under the control of trustees. The Group contributes 5% of relevant payroll costs with the maximum monthly amount of HK\$1,500 to the MPF Scheme, which contribution is matched by employees.

Under the Option Scheme, the directors of the Company may grant options to any full-time or part-time employees, executives or officers of the Company or any of its subsidiaries; any directors (including non-executive directors and independent non-executive directors) of the Company or any of its subsidiaries; and any advisers, consultants, suppliers, customers and agents to the Company or any of its subsidiaries. Upon acceptance of the option, the grantee shall pay HK\$1.00 to the Company by way of consideration for the grant.

The exercise price is determined by the board of the Company, and will not be less than the highest of (a) the official closing price of the Shares as stated in the Stock Exchange’s daily quotation sheets on the date of grant, which must be a day on which the Stock Exchange is open for the business of dealing in securities, (b) the average of the official closing prices of the Shares as stated in the Stock Exchange’s daily quotation sheets for the five business days immediately preceding the date of grant; and (c) the nominal value of a Share.

The maximum number of shares in respect of which options may be granted under the Option Scheme must not in aggregate exceed 10% of the total number of Shares in issue immediately following completion of the public floatation, being 100,000,000 Shares, excluding for this purposed Shares which would have been issuable pursuant to the over- allotment option and options which have lapsed in accordance with the terms of the Option Scheme (or any other share option schemes of the Company).

Besides, the total maximum number of shares which may be issued upon exercise of all outstanding share options must not exceed 30% of the issued share capital from time to time. The total number of Shares issued and which may fall to be issued upon exercise of the options granted under the Option Scheme and any other share option schemes of the Company (including both exercised and outstanding options) to each eligible participant in any 12-month period up to the date of grant shall not exceed 1% of the Shares in issue at the date of grant.

The amounts of the Group's reserves and movements therein are presented in the consolidated statement of profit or loss and other comprehensive income and consolidated statement of changes in equity.

(b) Nature and purpose of reserves

(i) Share premium

Under the Companies Law of the Cayman Islands, where a company issues shares at a premium, whether for cash or otherwise, a sum equal to the aggregate amount of the value of the premiums on their shares shall be transferred to share premium account. The application of the share premium account is governed by the Companies Law of the Cayman Islands. Share premium of the Company is distributable to shareholders subject to the provisions of the Company's Memorandum and Articles of Association and provided that immediately following the distribution the Company is able to pay its debts as they fall due in the ordinary course of business.

(ii) PRC statutory reserves

PRC statutory reserves include statutory surplus reserve and discretionary surplus reserve.

According to the relevant rules and regulations in the PRC, subsidiaries of the Company established in the PRC are required to transfer 10% of their profit after tax, as determined in accordance with the PRC accounting standards and regulations, to the statutory surplus reserve until the balance of the reserve reaches 50% of their respective registered capital. The transfer to this reserve must be made before distribution of dividends to owners of these subsidiaries. Statutory surplus reserve can be used to set off previous years' losses, if any, and may be converted into capital in proportion to existing equity owners' equity percentage, provided that the balance after such issuance is not less than 25% of their registered capital.

Moreover, upon approval by the equity owner, a subsidiary of the Company transfers 10% of its profit after tax, as determined in accordance with the PRC accounting and regulations, to the discretionary surplus reserve.

(iii) Special reserve

Special reserve arises from the issue of a company's shares in exchange for the shares of companies being acquired, and represents (a) the difference between the nominal value of the Company's shares issued and the value of the shares of Jolly Success International Limited ("**Jolly Success**") acquired, (b) the difference between the nominal value of shares issued for the acquisition of Treasure Resources by Jolly Success and the paid up capital of Treasure Resources, and (c) the difference between the nominal value of shares issued by Treasure Resources for the acquisition of Jiangxi Jinyuan and the net asset value of Jiangxi Jinyuan.
